# Annual Business Meeting Wednesday, February 12, 2020

#### Call to Order

The Annual Business Meeting of Bridgewater Baptist Church was held on February 12<sup>th</sup>, 2020. There were 84 members and several non-members in attendance. Gordon Fevens, Moderator, called the meeting to order at 7:04 p.m.

#### **Devotional Prayer**

Rev. Aaron Kenny was asked to take the floor and gave a brief devotional based on Jeremiah 29:11 – For I know the plans I have for you, declares the Lord. Plans to prosper you and not to harm you, plans to give you hope and a future. Pastor Aaron reminded us of the context of this verse within chapters 28 and 29. The people of Israel were captives in Babylon because of their disobedience to God. They were in a terrible situation and another prophet was telling them that things would get better very soon. God told Jeremiah that their circumstances would not improve for many years but that they should live their lives knowing that God does have a plan even when it is not obvious or change is slow to happen. God does not promise to remove us from the situation but to use whatever comes for our ultimate benefit and we can trust always in God's plan for our lives. After the devotion Pastor Aaron led us in prayer.

# Welcome/Quorum/Agenda

Gordon welcomed everyone, a count was taken of members present and the rules of order were read. Gordon asked if there were any changes to the Agenda and other that two typing errors, The date of the Special Business meeting in point 7 should read November 10, 2019 not 10, 2019 and the Annual reports referred to in point 10 were from the year 2019 not 2020 he declared them approved.

Moved by Terry Naugler, seconded by Don Lantz to approve the minutes of the Fall Business Meeting of October 9, 2019 and the Special Meeting of November 10, 2019. **Motion Carried.**

#### **Annual Reports**

The reports, as presented in the 2019 Annual Report pages 8-30, were reviewed. Sylvia den Hollander made one correction to the report. The interest rate listed on the Endowment report (pg. 27) should read 3.5% not 3%. David Haughn moved to accept the reports as corrected Jacquie Milliken seconded. **Motion Carried**.

#### **Opportunities for other Boards/Committees**

There were no other Boards or Committees wishing to report.

#### **New Business**

David Rafuse was asked to take the podium and provided a brief summary of the financial position of the church for 2019. He and Pastor Aaron announced that the mortgage now stands at under two million dollars, a huge step forward. We still need to continue moving forward with both regular payments and lump sum payments in order to pay it off as quickly as possible. David Rafuse then moved to receive the Statement of Revenue and Expenditures for 2019 and the Summary of the Accounts. David Mitchell seconded. **Motion Carried.** 

Before moving on to the next order of business Paul Rand asked to make a comment. He celebrated that fact that the church has come so far is such a short time. Given that the total cost of the building was over 6.3 million and we have only been here not quite five years it is truly a huge step forward to be under the 2 million mark and a sign of God's blessing.

David Rafuse moved to accept the proposed Budget for 2020. David Haughn seconded. **Motion** Carried.

It was moved by David Rafuse and seconded by Paul Rand that Belliveau Veinotte Inc. Chartered Professional accountants be appointed to complete a financial review of the fiscal year to end December 31, 2020. **Motion Carried.** 

Barbara Conrad moved to accept the Report of the Nominating Committee with one amendment. Charlene Rhodenizer's term on the C. E. & A. committee should be 3 years not 2 years. Marlene Conrad seconded the motion. **Motion Carried**.

Kathy Archibald moved that at the recommendation of the Board of Deacons we accept into membership Yvette Fisher by transfer from Greenfield Baptist Church, Amanda Silver by transfer from New Cornwall Baptist Church, Sydney Grant by baptism in February 2020 and Matt Naugler by baptism later in 2020. Seconded by Michael Doré. **Motion Carried.** 

# **New Business**

Gordon Fevens then asked if there was any new business from the floor. Janice Rand asked to speak regarding a Trail Run fundraiser that she is planning for October 3<sup>rd</sup>. This will require the help of many volunteers. Please see her if you are interested in helping.

#### **Closing Prayer**

Rev. Richard Moore was then asked to close the meeting in prayer. Meeting was adjourned at 8:15 p.m. on the motion of Norman Hovland.

# **Lead Pastor's 2020 Report**

"Where shall we buy bread for these people to eat?"
He asked this only to test him, for he already had in mind what he was going to do."

John 6:5-6

A year ago, we had little idea of the challenges we would face in 2020. Certainly this past year will be etched into our memories. We all have stories to share, some more painful than others, as we weathered highs and terrible lows. It is remarkable how the Lord meets us in such times of great upheaval and the unexpected way he works even through times of distress and loss.

I'm reminded of occasions in the Gospels when the disciples became overwhelmed by the uncertainty and dangers they encountered, only to discover that the Lord already had a plan for how he would use their little faith for great things.

Do you remember that scene on the hillside when Jesus looked out and saw 5000 hungry people? Jesus saw the need and was moved to provide for the welfare and well-being of the people. For the disciples, the cost and logistics of meeting such a great need seemed outrageous. They hardly had enough to take care of themselves let alone thousands of others. And yet Jesus asks them to respond to the need.

It was a defining moment when Andrew stepped forward with a little boy, who offered the bread and fish he had packed for his own lunch. He gave to Jesus the little he had, and God used it -- not only to feed a lot of people, but also to show them his compassion and his power.

God always starts with what we have. You may feel like you do not have much to give. Perhaps your time is already so full; your finances seem too low; your talents feel too rusty. What do I have to offer him? As we've been reflecting together in worship during the start of 2021, God desires everything in our lives. Give him your heart. Give him your reputation. Give him your past, present, and future -- Hold nothing back! It may not seem to be much, but you can give him your five loaves and two fish.

Jesus wasn't worried about how to feed 5,000 people. He already had in mind what he was going to do. He saw the need long before the disciples did. And he had a plan.

We need to understand this truth today: God always has the answer before we even know the problem. God is not worried by what may appear to us as insurmountable. It's never too late in the day for Jesus. He sees our problems long before any of us recognize them. He knows what is coming, and he already has a plan for it.

As we look back on 2020, it is encouraging to see how the Lord has brought us through so much. On March 15, we concluded our in-person services as our province went into a state of emergency on March 22. Our leadership team of pastors, deacons, and elders unanimously agreed to temporarily shut down the church building and to migrate services and ministries to online platforms. Little did we know that as a congregation, we would not return to the sanctuary for another 24 weeks! In the months that followed, we worshipped each week through video streaming and radio broadcast; held Bible studies, prayer gatherings, and youth groups over Zoom; hosted parking lot services, and shared weekly communication through email updates. We offered the Lord the little that we could.

One of the greatest challenges in the pandemic was the need to keep everyone connected. In our congregation of 310 active members, we have 120 households without reliable Internet access. There were some simple, but important ways that we responded. Across the congregation, we saw people answer a challenge to phone others in the church directory. People stepped forward to run errands for shut-ins, and to help where needed. In addition, the pastors and board of deacons committed to calling every home in our church directory so that hopefully no one would fall through the cracks. We also started a weekly dial-in ministry where each member of the pastoral team shared devotional talks and prayers. Through this ministry we received prayer requests and inquiries for visitation. In our brokenness, the Lord was moving.

In addition, to using the telephone to connect with people, we produced regular mailings, many of which were hand delivered by volunteers in the church. For the first time ever, our fall business meeting was replaced by written reports and decisions temporarily delegated to the board of elders. A decision that has continued for our Annual General Meeting that would have happened in February 2021 under normal circumstances.

With a strong desire to return to in-person gatherings, we launched a summer drive-in service in August 2020, as well as outdoor hymn sings and music events on Sunday evenings. A big thanks to pastor Erica Kenny, Jeff Vanderwal, Debbie Zwicker, and our summer student Cassie Oakes for all their dedication to the outdoor services. We also share our gratitude to Susan and Eric Pettigrew, our board of trustees and deacons for their contribution in implementing our COVID-19 preventative measures to providing order and support for people coming and leaving these gatherings.

As we sought to extend the message of hope in Christ throughout our community, another major addition was the introduction of our church radio broadcast on 98.7 FM -- our very own Bridgewater Baptist station. Again this took great effort from pastor Erica Kenny and Jeff Vanderwal who worked together to spearhead this project and gain necessary certifications for the church. Since August, our services have been broadcast each Sunday throughout our community. At a time when churches and community organizations across North America were scrambling for radio broadcast equipment and bidding wars were happening over a scarcity of supplies, the Lord led us to a gentleman who had once been blessed by the generosity of Bridgewater Baptist Church. He sold to us equipment that could have cost us ten times the price. Each month we continue to hear from people who are blessed by the radio broadcast.

With the strangest of years behind us, entering 2021 has been more than a relief for many in our church and community. We are ready to turn the corner on COVID-19, to move beyond the fractured politics and public discourse of the last year. Surely there are better days ahead. And yet, as I talk to people I know many are still worried. The vaccination program will take many months to fully roll out and even with a vaccine there will be many precautions for us all to follow. The road ahead is long.

If you are feeling weary or discouraged, take heart. The Lord sees the challenges that we have not even yet perceived; He has a plan, and calls us to join him, by holding nothing back. Just watch him take your loaves and fish and turn them into a feast!

I am so thankful to our Summer Intern, Cassie Oakes, who shared her amazing gifts and leadership through the challenging summer months.

Looking back on the last year, it has been exciting to see new ministries emerge in our church such as Alpha, Prayer Shawl and Sacred Pathways. Each of these have been strong ways of deepening relationships within our congregation and community.

Sylvia den Hollander completed her role as Administrative Clerk after many years of service with BBC. With her departure, I began to take on new responsibilities that fit with my own sense of calling and gifting. In conversation and prayer with our Board of Deacons, we discerned that the Lord was leading us to re-visit the ministry needs of the church. Together we are in the

process of reshaping my associate pastor role to focus on ministries of outreach and administration.

Looking ahead to 2021, I am so thankful to work alongside our Board of Deacons and the leadership of our boards and committees in the areas of outreach and administration. As we continue to live in the reality of the pandemic, God continues to prepare us for new opportunities to join Him in his mission to love His people. God is faithful – AMEN.

# **Pastor of Visitation's Report**

The year 2020 was a year of change. I am thankful that the steadfast love of the Lord never changes. His mercies never come to an end. They are indeed new every morning. Due to COVID- 19 my usual visits to people's homes, hospitals and nursing homes came to a halt. I then moved to a phone ministry for the shut-ins to keep everyone safe. I will continue to reach out to the church family this way and when opportunity is provided I am happy to come to your home if you are comfortable and it is safe.

But as we know the Lord is always going ahead of us and I am grateful that I could provide for the church family and community the GriefShare ministry. Providing a support group for so many that are grieving the loss of a loved one and needed a safe place to share was rewarding. The program has teachings from specialists in the area of grief and the teaching and bookwork brought healing to many. I was so appreciative that Grace Rafuse and Janice Rand came along side me to share in the leading of this ministry in the various groups.

Each course is 13 weeks long and we were able to run 3 complete courses this past year. Each group registered an average of 12 people so it allowed many to be a part of this ministry. We are gearing up to start our 4<sup>th</sup> cycle this January. The course when safe, is hosted at the church and when needed is available to anyone over Zoom.

The Lord laid on my heart the desire to provide a bible study, first of all for those attending the GriefShare group, so that they might continue meeting together and support one another. This opportunity is available to the group as well as the church family at large. It is my goal to continue providing ways to bring us together and strengthen our faith in the word of God for every area of our life. We completed a study on Psalm 23 and are currently studying Psalm 119. We are using Matt Chandler's teaching on these wonderful scriptures to help us persevere in our faith. We invite anyone to join us at any time. All you need to bring is your bible.

# **Board of Elders**

The Board of Elders consists of Susan Pettigrew, chair of the Board of Trustees; David Rafuse, chair of the Board of Finance; Kathy Archibald, chair of the Board of Deacons; as well as members at large Trina Mitchell, Terry Naugler, Sylvia den Hollander, Jacquie Milliken (secretary), Gordon Fevens (vice chair), and Tim Snyder (chair), as well as ex-officio members Aaron and Erica Kenny.

With 2020 being the year that it was, the Board of Elders did not hold regularly scheduled, face to face meetings as has been the practice in previous years. Instead, issues were dealt with on a case by case basis, virtually, via email. A somewhat slower process to be sure, but effective in ensuring that provincial COVID guidelines were met and participants were kept safe.

Since the Government imposed shut down last spring, The Board of Elders has been involved with a number of decisions regarding the operation of the church, including approval of the use of funds from the Memorial Fund for the purchase of a FM transmitter for service broadcasts. Approval of guidelines for limited reopening in September, approval of preparations for the church yard sale in September, as well as the decision to cancel the Fall Business meeting and include reports in the October Thanksgiving letter.

In mid-December, we received a unanimous recommendation from the Board of Finance regarding our mortgage. They had received information from the Atlantic Baptist Foundation explaining a new lending policy that would come into effect Jan 1, 2021. ABF now extends loans for a one-year period only, and lending rates will be the same as posted deposit rates. Because our current mortgage term at 3.8% does not expire until September 1, 2024, we would not be affected by this new policy until then. However, ABF offered us an opportunity to opt-in early and take advantage of current lower interest rates. Based on the information gathered by the Board of Finance and their recommendation, as well as discussions by the Board of Elders, it was a unanimous decision to take advantage of this opportunity. As a result, just before Christmas, an amendment to our mortgage was signed, by myself, on behalf of the Bridgewater Baptist Church, for a one-year term beginning Jan 1, 2021, ending Dec 31, 2021 at 2.2%. I understand that, normally, a decision like this would be made at a business meeting, but these are not normal times. It is not the intent of the Board of Elders to remove the congregation from the decision making process, but to make the best decisions we can on behalf of the congregation until things return to something closer to the normal we used to know, and safer than the "normal" we now have.

#### **Board of Deacons**

To say 2020 was a year like no other would be an understatement. It was certainly a challenging year with many uncertainties and unknowns although it didn't start out that way. January, February, and March meetings of the Board of Deacons were conducted as per usual with the monthly meetings taking place on the first Thursday of each month. Suddenly, we were in the midst of the pandemic and under complete shutdown. But God provided us with wonderful leadership in our Pastors and Church Boards who were able to adapt and adjust to rapidly changing conditions.

The Deacons continued to meet during April and May using Zoom technology as well as via email and over the phone. Since June, when the church re-opened, we have been able to safely gather in the church chapel while social distancing and following NS Health guidelines.

The Board approved the purchase of the equipment for a 50W radio broadcast system enabling the drive-in services as well as our service going out to the community over channel 98.7 FM every Sunday. When the sanctuary was opened for in-person services, we decided to purchase and use pre-filled, disposable communion cups. This decision was met with a very favourable response.

After much deliberation and prayer, the decision was made to not fill the position of Church Administrative Clerk. The Deacons are working with Pastor Erica to review and update her job description to better use her gifts and talents. This will include taking on the financial duties, part-time administrative role while continuing to use her gifts in Outreach ministry.

The Board continues to respond to congregational concerns with the use of the Benevolent Fund and have continued to support Peter Young's initiative in the Ukraine. A decision was also made to provide monetary support to Gwen Rowe for her ministry in Mexico. The Board participated in the annual staff reviews and in completing the 2021 budget submission.

Three new members have been welcomed into membership and two candidates have been interviewed for membership. There are still two baptisms to take place when the COVID restrictions are lifted.

#### **Board of Trustees**

Due to COVID- 19, the trustees met three times in 2020. The trustees continue to monitor the building and church property for any maintenance that needs to be done. Andy Veinot did a performance evaluation of the heat pumps to ensure they were working properly. Day Spring Electric replaced a pump that was overheating.

When the province shut down in March and we were not sure when the church would reopen, we took measures to reduce spending by turning off the heat in the main part of the building and the heat/cooling system for the gym was also turned off. The three hot water tanks were turned off. The custodians, Russ and Heidi Mead, were laid off.

In September, a high traffic section of the parking lot was sealed and parking lines were repainted. Handicap spaces were increased from 5 to 9.

During the month of August, the trustees coordinated the parking for the drive-in services and assisted in ushering for the month of September.

In September, activities began to resume and Heidi and Russ were reinstated. Extra cleaning has been going on as per Nova Scotia guidelines. Sanitizing stations and supplies have been added where needed. The heating/cooling system was turned on and one hot water tank. LaHave Paving have been contracted for snow ploughing and salting of the parking lot for 2021.

An election for Chair, Vice Chair and Secretary will take place during our next meeting (February).

The pandemic obviously had a major impact on our Baby, Child & Youth Ministries, Bible Study Groups, Cradle Roll, Tot Time, Library, Easter Morning Programming, Grad Sunday, Cookies and Lemonade, the Big Ex Parade, VBS, and Summer Ministry, as well as our events like Community Clean Up, Blessing of the Backpacks, Pumpkin Palooza, Church Family Potluck, Long Lake Camp gathering, Christmas Concerts, Winter Fun Day and more.

However, after a lengthy hiatus, October was effectively our first meeting of the fiscal year, which was held to discuss a couple things we hoped to still be able to do: White Gift, and potential fall/winter recreation activities. Truth be told, it was wonderful to see faces again and share a room together, even with masks and a six-foot distance. There was something powerful and emotional about simply being together again and praying together for that first time after such an absence.

Following our February 2020 Annual Business Meeting, our first event had been the LCLC Winter Fun Day planned for March Break. So, we were excited to have been able to book another such Fun

Day for the Christmas holidays, only to have to cancel that too following the increased restrictions back in December.

Thankfully, with some adjustments, we were able to discuss an outdoor walk that began as a replacement for our fall gathering (PumpkinPalooza). Erica reached out to our resident hikers, Janice Rand and Karen Toews (thank you both) and a new socially distant, safe-in-the-outdoors activity was born. After a few well-attended walks, we anticipate Sacred Pathways to be a regular and welcome addition to the life of our church and community in 2021 and beyond.

It made sense that White Gift would also need to look different this year. Moving away from tree tags in favour of cash-only donations made it possible for 2-3 committee members to do all the toy and clothes shopping. Instead of a wrapping party at the church, we bagged up items by family and sent them home with volunteers to wrap. Instead of our usual train of grocery carts at the store, 2 other volunteers handled all the grocery shopping. With some adjustments, we made it work, and with donations surpassing \$6800, God clearly showed us that being faithful to this need and caring for these 13 families and 29 children was exactly what He needed us to do. He certainly equipped us financially, but he also did so within the hearts of the givers, the hands of volunteers, the prayers of the BBC church family, and even words of encouragement as delivery people stood at the doorsteps of recipients to share love and joy over what was a tremendously difficult season for so many. We were indeed very well equipped. There is a great lesson in this for me and for all of us. We are told in black and white within the word of God not to worry, yet it tends to find a way to creep in. In this unprecedented time in history, it is more important than ever that we *really* give it all to God. He will be our supply. Our job is to trust and obey in loving Him and loving each other. It's not always easy, but it sure is simple.

It is our collective prayer as a committee that we all continue to be beacons of light as we move in to the year of unknowns that lies ahead.

We have also started (Jan – March) giving clients an appointment time so they aren't waiting in the cold weather for long periods of time. We serve 3-4 clients every 15 minutes.

# **Board of Finance**

Many of you already understand that the year of 2020 had been a difficult one on many fronts. Illness and loss of life caused by this ongoing pandemic continue to haunt us. The ability to openly worship free of restrictions is still a distant hope.

Through all of the above many of you in the congregation have stepped up to ensure stability in the funding of church and ministry.

For the year 2020 all operating expenses of the church have been paid, monthly mortgage requirements have been met, and mission support remained strong. We are so blessed that through adversity we grew stronger as a committed congregation supporting the financial obligations placed before us.

A review of our Income Statement for 2020 shows total giving at \$293,185.00 with operating expenses of \$279,185.00. This leaves us with a surplus of \$14,000.00. It is true our giving was worse than budget by \$24,115.00. The good news is that expenses were cut by \$38,115.00 when

compared to plan. Many areas within the church stepped up to help reduce costs during the several months of COVID- 19 impact. That posture continues into this year (2021) as we address ongoing concerns.

Throughout the year we have seen strong financial support for mission commitments. Income (giving) for the year at \$67,397.00 surpassed plan by 7%. This allowed fulfillment of all budgeted financial expense obligations.

On the mortgage front we have seen our principal owing drop by \$206,824.00 (10%) during the year. Our mortgage interest rate started the year at 4%. Part way through the year it dropped to 3.8%. Starting January 1 of this year (2021) its now 2.2%. Over the life of our remaining 9-year mortgage (\$1,774,732.00) these dramatic reductions in interest charges will save our church many thousands of dollars in expense. In spite of rate reductions, we continue to pay \$16,825.00 in monthly mortgage amounts. This aggressive approach allows our principal owing to be retired more quickly. Failure to do so would extend our mortgage payments to 14 years. We are so fortunate to be in partnership with the Atlantic Baptist Foundation, holders of our mortgage. Their strong faith based principals are enabling this church to work towards retiring its mortgage sooner than originally expected. There is no question that your ongoing support in the building fund area is desperately needed to keep our plans on course.

Our Operating Budget for year 2021 in part reflects the reality we all face as this pandemic continues to rage. Once again we are presenting a balanced budget (revenues equal expenses) for approval by the congregation. Revenue expectations of \$285,000.00 have been offset by church operating expenses of equal value.

As many of you know our church Administrator Sylvia Den Hollander has now left office responsibilities behind as she embraces full time retirement. Our Board of Finance over the last several years has relied heavily on the expert financial guidance provided by Sylvia. Her contribution to Board activities has been integral to the success of effectively discharging our responsibilities. Sylvia's extensive knowledge and deep commitment to this church have been most appreciated by all in our group.

Our Board of Finance consists of 6 voting members and two Ex-Officio (non-voting) members. During this difficult year we convened meetings when necessary to ensure financial continuity as the weeks and months unfolded. Emails, phone calls, Zoom virtual sessions, and actual face to face meetings were held to deal with issues placed before our team. Proper protocol measures were followed to ensure the safety of all participants.

With Terry Naugler as Vice Chair and Cheryl Allen as Secretary meetings were well organized and thorough. Marie Langille, Irene Conrad-Mackay and Gerald Penny round out our group of well qualified voting members. We are most blessed for their tireless volunteer involvement. Ex-Officio Members Lead Pastor Dr. Aaron Kenny and Associate Pastor Erica Kenny now complete our Board and provide valuable leadership input. Rest assured you are well served by an engaged Board determined to do its best in serving the needs of our church.
